September 23, 2021 Regular Board Meeting

The Park Hill Board of Education held its September 23, 2021 Regular Meeting at 6:30 p.m. in the Board Room at the District Office, 7703 NW Barry Rd., Kansas City, MO 64153.

1.1 Call to Order

The meeting was called to order at 6:30 p.m. by President, Janice Bolin.

1.3 Announcements

Dr. Cowherd addressed concerns that the district isn't doing anything about what happened at Park Hill South High School. "This racist incident is unacceptable and will not be tolerated," she said. Dr. Cowherd shared the details of the district's policies that prohibit discrimination and harassment and say that "students who violate this policy will be subject to discipline, which may include suspension or expulsion." She also stated that the Park Hill School District has a problem that must be addressed.


